## Disability question resolved

- Update from STC: "The definition of a person with a disability in the target group profile that you have
  is someone who answered Yes, sometimes or Yes, often to either of the questions on the census
  form (Q7 or Q8)."
  - Q7: "Does this person have any difficulty hearing, seeing, communicating, walking, climbing stairs, bending, learning or doing any similar activities?"
  - Q8: "Does a physical condition or mental condition or health problem reduce the amount or the kind of activity this person can do?"

#### Notes:

- Issue with 2011 NHS disability data -- nomenclature is different, and there is a caveat associated with false positives (this latter was similar for the 2006 Census)

- Place of work data -- which variables to include? (NOC, NAICS, educational attainment, etc.) -- To discuss at next mtg
  - Variable (7 categories)
  - Place of work side of Census/NHS database
  - o lan can send titles of tables used in Place-of-work data

#### Notes:

- WG okay with ordering non-shaded cells initially, and adding more complicated crosstabulations (orange-shaded cells) to a later fully custom order if there is sufficient interest
- ACTION: CDP to order non-shaded cells
- W/r to red- and orange-shaded tables, in order to reduce the number of IVT tables required, it is possible to:
  - Not crosstabulate everything
  - Use simpler variables
  - Remove certain variables
- Place of work
  - To begin thinking about what profiles/crosstabulations to order
  - Technically, any Census variable is possible, but the population is the employed LF (15+, employed)
- ACTION: Brendan to distill BC's transportation orders and generate a tentative list of variables of interest

## Website upgrade and user testing

- We encountered certain technical hurdles that have delayed launching an improved catalogue -- we will continue working on this through the fall
  - Until then we will continue to catalogue <u>new datasets</u> with more metadata than <u>datasets in</u> <u>previous program cycles</u>
- We are in the process of migrating from Drupal 6 to Drupal 7 (simple upgrade)
- We will need WG members to check the test site (cdc.jungle.ca) for glitches, bugs, etc.
  - a. Registering a user account
  - b. Finding and downloading a table
  - c. Anything that comes to mind
