Acquisition updates

Census tables available in the catalogue:

- Labour Force Status (8), Highest Certificate, Diploma or Degree (15), Age Groups (13), Admission Category and Applicant Type (8) and Period of Immigration (13), for the Population Aged 15 Years and Over in Private Households of Canada, 2016 Census
- Household Contributions to Registered Savings Accounts (18) and Selected Characteristics (30) for Private Households in Canada, 2016 Census

- Household Living Arrangements (12), Age Groups (23) and Sex (3) for the Population in Private Households of Canada, 2016 Census
- Place of Work geography available for the Census Profile at CSD and CD level of geography. Put in another request for CT, ADA and DA.
- Calculated Financial Assets, 2016

TransUnion data

NMCD (full) data from TransUnion has been cataloged. Mortgage data to be delivered shortly. Credit risk and Bankruptcy Risk data have been delivered and will be cataloged soon. The data are not comparable to Equifax data. Fewer records than Equifax data, as TU does not aggregate suppressed records.

Welfare Incomes – compiled by Maytree (Caledon Institute wound down its day-to-day operations in 2017)

ACTION: REMIND STC OF PRIORITY

Calculated Financial Assets - methodology

The CFA table is based in part on grossing up the income from dividends reported on the T1 by the monthly dividend yield at the end of each month. The data from the Bank of Canada used to calculate the gross up rate was discontinued. Future requests for CFA will require that we provide STC with a gross up rate for dividend income.

Permanent Residents data cube

Not coming soon, will likely start with CMA data, less-detailed CSD data would follow, production moving to STC

IRCC data being housed and distributed via STC. Don't know yet what data will look like. CLIP working with IRCC and STC to work it out.

Non-permanent residents

Not possible to get Census data on non-permanent residents.

Priorities for tables at custom geographies

Discussion of priorities for tables to acquire at custom geographies. Melissa Kelly presented the rationale behind the priority tables requested by the LIP pilot project, several of which will have other uses besides studying immigration trends. It should also be noted that the requests made by the LIP pilot project are effectively coming from a significant number of member organizations.

ACTION: DPAWG members requested another cleaned-up version of the priority file, separating out tables that are already in production.

Census product acquisition file

A simpler version of the product rating file has been adapted to indicate what Census products we have already acquired, will be acquiring soon, or are considering acquiring. A first draft of this file will be sent to the DPAWG members for review.

Collective dwellings table specs

Revised specifications for this table will be sent to the DPAWG members for review. The 'Language spoken most often at home (8)' dimension has been removed and higher income groups have been consolidated.
