### *Data Party*

**Data party description:** Join colleagues from the Community Data Program and jump into newly released data sets. Our first data party will celebrate the arrival of the much awaited results of the 2016 Census. Woohoo! The data is here! Now what? The party will kick off with a few of the highlights from the Daily (Statistics Canada) and then we will hear what our colleagues are up to and what surprises they are seeing in the data.

We are thinking of an early November data party, after the immigration release but before the final Census release. We don't want to push the data party into December. The basic structure will be: what are you doing with the data? Would there be any members who would take this



on and present – to help facilitate discussion? We can make use of Adobe Connect's polling features and ask questions! This will drive discussion as well.

**Jasmine Ing:** Will the answers from the polls be visible to the other party participants? It would be great to see the answers!

**Julie Lam:** We can broadcast the answers.

**Jasmine Ing:** For your awareness, we cannot move the poll questions around in the screen, so the presenter should take care to place them in a good spot.

**Jasmine Ing:** We can potentially be one of the presenters.

We can have these data parties a few times a year.

**Ted Hildebrant:** So, do we have set date for the data party?

Right now, now specific date, however, we are looking at early November. Would that make sense to the group? Would a full week after the release... or two full weeks after the release be preferable?

**Aaron Mulcaster:** Two weeks would be better.

**Ted Hildebrant:** Further out, a week at least.

**Jasmine Ing:** I actually think closer to the date is good. One week is good for us, but we can wait if that is the group consensus. The information would be most useful to us close to the release date.

**Jasmine Ing:** I know Toronto does release a document the day the data is released. it may be worthwhile to see if they would be willing to be a presenter

We will send out an email for potential dates closer to the release.

### *Snapshots*

We are taking a more active role in getting snapshots. These are great for new members to see how others are using CDP data. Emailing member organizations and expecting a reply has been difficult – so Julie has been calling organization and interviewing some members. If any members in the working group know of any organizations using CDP data, please forward it to us!



**Jasmine Ing:** Julie, you can do a phone interview with me if you like.

**Julie Lam:** Thank you, will do!

### *Website refresh*

The terms of reference are set – we are expecting a whole new look and feel for the CDP. Also looking to expand and develop new tools in the resource section. Will have some “how-to” videos added to the site, as well. Anticipating a new dashboard to help measure how resources and the website is being used. Hopefully, before Christmas we will have some information for the members. The whole refresh should happen March next year.

**Katherine Scott:** We will have the opportunity to consult the members after Christmas. We want to consult the members on functionality and new tools – to better track your own members and more. We are excited for this! Currently interviewing potential contractors.

**Natalie Hui:** Tracking of one's consortium members' usage of the website would be very helpful for our follow-up with them on how they could better leverage the website.

### *Envision*

Envision use remains low with the exception of one or two regular users. We have brought this up before and seems like the CDP may not need Envision.

**Jasmine Ing:** I don't think it matters to us if the envision license is discontinued. We would probably prefer the money go elsewhere.

**Katherine Scott:** Not sure that we are cutting all licenses – we will need to consult first. But the number will be cut and funds redirected.

### *Webinars*

There are 2 webinars coming up in October. On Thursday Oct 5, there will be a webinar presented by Gillian Kerr, who will talk about a new Service Information System being developed.

The other webinar is a CDP orientation on Wednesday Oct 11 – this is a refresher. There are lots of information on the site already but some people like to have real-time participation.

If your consortium would like your own orientation at a separate time, please let us know and we can do that.

**Katherine Scott:** Perhaps we can prepare an invitation for leads to distribute to their members or new members for the orientation webinar. Just a thought.



**Natalie Hui:** Could we invite non-members, but who have shown interests in joining the consortium to attend the orientation webinar?

**Katherine Scott:** Absolutely - the orientation sessions are good marketing opportunities.

**Natalie Hui:** Great!

**Laurie Dixon:** We are thinking of tagging on to the orientation webinar, would we be able to view it before hand to help facilitate the local discussion?

**Katherine Scott:** And we will be breaking down this material in shorter videos to post on the website.

**Laurie Dixon:** Great thank you.

### *User Survey*

Generally, we can keep the same questions and format, but can remove the question about the website and LISTSERV. If anyone has any suggestions, let us know!

**Jasmine Ing:** Do you want work areas? My organization (the City of Calgary) is none of those things, but my work area fits into one of those.

- What about "how often do you use community data"?
- Do you publish data from the CDP?
- Have data from the CDP informed any decisions for your organization in the past year?
- How many people access data from the CDP at your organization?
- Do you consider yourself a beginner, intermediate, or advanced user of community data?
- Have you participated in any CDP learning opportunities (watching videos, participating in webinars, data parties, etc)?

It would be good to ask "what are you using CDP data for?"

**Katherine Scott:** This is our primary opportunity to ask about program impact - happy to receive any and all ideas. We can supplement with web analytics.

We will compile some questions for the survey and have them sent out to the group.

### *Leads teleconference meeting*

This is coming up in 2 days. There will be an update from the TCBWG during the meeting. It would be great to hear from other members as well. Let us know directly if you want to speak about anything, or if you would like us to pass on any information or suggestions at the Leads' meeting.
